

Apply for Professional Childhood Grades 1-6 Certification on TEACH

Program codes for Professional Certification are linked to the specific completed master's degree program. The Curriculum & Instruction master's degree program has been approved by New York State to lead to a college recommendation for Professional Childhood Grades 1-6 certification. It has also been approved to lead to a college recommendation for Professional Early Childhood B-2 Certification and the Initial/Professional Gifted Education extension, depending upon the specific coursework completed.

Select "TEACH Online Services"

Select "Apply for Certificate"

Make selections from the drop boxes to select certificate title:

Title: Childhood Education Grades 1-6
Type of Certificate: Professional Certificate

Answer yes to the question regarding enrollment in or completion of an approved teacher preparation program for the title and enter the program code **25220**.

Select the **Approved Program Certificate Progression** pathway for this title

If the college recommendation for this title has already been posted to your TEACH account, you will not need to enter the program code. TEACH will automatically select the pathway for this application.

Answer the moral character questions and electronically sign affidavit

Submit \$50 application fee online using a credit card

Request that your district(s) verify your mentored and teaching experience. Employers located in New York have the option of entering an electronic Superintendent Statement (Verification of Teaching Experience) onto the applicant's TEACH account. **This is the preferred method of verifying experience.** However, if the employer is not located in NYS and/or cannot verify experience using this method, they can submit the [Verification of Paid Experience Form For Teachers](http://www.highered.nysed.gov/tcert/pdf/ot-verifexper-teacher.pdf)

If you are eligible for a college recommendation for Professional Early Childhood B-2 Certification and/or the Initial/Professional Gifted Education extension, you will use the same program code (25220).

If you hold Initial Certification in Early Childhood B-2 and/or the Gifted Education extension, but are **not** eligible for a college recommendation based on the coursework completed in the Curriculum & Instruction program, you will use the instructions below to apply for the Professional titles.

For all other professional titles, leave the program code box blank and answer no to the question regarding an approved teacher preparation program. The appropriate pathway should be **Certificate Progression**. Send transcripts that reflect the conferral of your master's degree to NYSED.
